#### **FRIENDLY REMINDERS:**

Smoking Policy: Smoking is prohibited anywhere along the facility not designated as a smoking area in accordance with Guam Public Law 33-121. Please advise all personnel, visitors, and customers not to smoke near the building. There are designated smoking shelters located in the lower parking lot.

Parking: Parking rules are strictly enforced here at the Guam Integrated Air Cargo Facility. Please advise all guests not to park in the fire lines, behind other cars, etc. Vehicles found in unauthorized parking areas will be towed at the owner's expense. Please help us keep the fire lanes and loading bays clear for safe loading and in the event of emergencies.

**Visitor Screening**: For everyone's safety, all visitors entering this facility are logged in and must provide a valid Driver's License prior to entry. Visitors without proper identification will be asked to park outside and walk/shuttle to the office they are visiting. We appreciate your cooperation in this matter.

## **New Tenant Lanes Coming Soon - Update**

We experienced a delay with the arrival of components of our Parking Ticketing Machine and Card Reader equipment. They equipment has arrived and installation will begin December 13, 2018. We anticipate opening the second lane for exclusive use of our Tenants shortly after. There will be new signs posted at the facility entrance designating Visitor and Employee Entrance. All Tenant employees will be issued gate cards that will allow them to drive up to the machine on this lane, swipe their card for entry, and proceed into our secured facility. The gate card will be assigned specifically to every employee based on a list provided by all Tenants. The card will show the employee's name and company he/she works for at the Guard's security screen upon swiping at the gate entrance. The left lane will remain open for visitors. This will help solve the congestion at the gate while our Security screens all visitors allowing Tenants to have a separate free-flowing entry point. We request that all Tenants keep their Tenant Cards secured. Sharing Tenant Cards will be strictly prohibited as it compromises the safety and security of the employees in this facility. Lost or stolen Tenant Cards can be replaced at our Office for a fee of \$5.00.

# **Barbecuing in the Facility**

With the holidays upon us, we have been receiving requests to have small gatherings and/or employee barbecues on the facility grounds. We want to re-iterate that any employee barbecue/party on the facility grounds must be approved through our office. For the safety of our facility and employees, we have put together the house keeping rules when deciding to plan an employee barbecue.

- Notify the PAP Management Office at least 48 hours prior for clearance and approval to use the common facility grounds (designated bbq area).
- All barbecuing activities must be done in the designated grass area beside the Mechanical Shop. No barbecuing is allowed near the facility.
- We request for all outdoor parties/barbecues to be scheduled on weekends when traffic congestion and tenant operations are significantly slower.
- Absolutely no alcohol is allowed on the premises.
- For fire safety, a handheld fire extinguisher must be present beside the barbecue grill.
- PAP Management Office and Security Personnel reserve the right to end any barbecue activity if the party employees or guests become disruptive or is caught disobeying the building safety rules.
