## FRIENDLY REMINDERS:

**Smoking Policy:** Smoking is prohibited anywhere along the facility not designated as a smoking area in accordance with Guam Public Law 33-121. Please advise all personnel, visitors, and customers not to smoke near the building. There are designated smoking shelters located in the lower parking lot.

**Parking:** Parking rules are strictly enforced here at the Guam Integrated Air Cargo Facility. Please advise all guests not to park in the fire lines, behind other cars, etc. Vehicles found in unauthorized parking areas will be towed at the owner's expense. Please help us keep the fire lanes and loading bays clear for safe loading and in the event of emergencies.

**Visitor Screening**: For everyone's safety, all visitors entering this facility are logged in and must provide a valid Driver's License prior to entry. Visitors without proper identification will be asked to park outside and walk/shuttle to the office they are visiting. We appreciate your cooperation in this matter.

#### **New Tenant Lane Opening This Month**

Beginning next week, PAP will be issuing Tenant entry cards to all registered employees working at the Guam Integrated Air Cargo Facility. If you have not submitted your employee listing to



include vehicle license plate information, please do so as soon as possible to avoid any delays at the entrance.

Beginning next week, both entry lanes will be open. Lane 1 will remain an entry gate for visitors. The vehicle screening with security will remain in place for this lane. Lane 2 will be an exclusive lane for Tenant employees only. All employees with a registered entry card will be able to use this lane, swipe their card at the card reader machine and enter.

This will alleviate the congestion during peak hours while still allowing Security personnel to do the necessary screening and security checks with all visitors.

We ask that all employees please keep their cards in a safe place. Card sharing is absolutely prohibited. All cards will be registered to a specific vehicle for security purposes. As a reminder, card replacements will be issued when necessary with a replacement fee of \$5.00.

#### Solar Parking Lights - Update!

Thank you all for your patience as we temporarily close off some parking stalls to complete this project. Installation is still in progress and we are making every effort not to interfere with Tenant operations. We apologize for any inconvenience this may cause.

#### **Parking Stalls Re-painting In Progress**

You may have noticed some housekeeping ongoing in the parking lot and curbs. We are in the process of repainting all parking stalls, vehicle arrow lanes, and sidewalk curbs to make them more visible for safety reasons. Most of the work is being completed on the weekends and after hours so as not to interfere with Tenant operations. We ask for your patience as we work around your areas and normal parking spaces. Weather permitting, this project should be completed by the end of this month.
